

Location and Venue

The in-residence component of the course is taught at the Sandy Bay Campus of the University of Tasmania. Welcome drinks will be held in the Law School. Most lectures will be held in the Harvard Lecture Theatres in the Centenary Building. The formal lunch will be held in the University Club.

The University of Tasmania's Sandy Bay Campus is approximately 10 minutes taxi ride from the city and 30 minutes from Hobart Airport (https://goo.gl/maps/e5PsUm66oZ72). The Law School is located on the corner of Alexander St and Grosvenor Crescent (if your taxi driver cannot find Grosvenor Crescent tell them Grosvenor Street).


